This notice describes the Information IFS may gather and the circumstances under which the information may be shared.

Why IFS Collects Information and How IFS Uses Information:

IFS limits the collection and use of information to the minimum the Firm requires in providing superior service to you. Such service includes maintaining your accounts with the Firm, processing transactions requested by you and administering Firm business.

How IFS Gathers Information:

IFS gets most Information directly from you through forms you complete, when you apply for, access and use financial products and services offered by our firm. The Firm may verify this information or get additional information from consumer reporting agencies or public sources. This Information may relate to your finances, employment, as well as transactions and interactions with our Firm or others.

Information IFS Obtains:

Customer Information. Customer information includes identifying information such as your name, address, telephone number, social security number, and demographic data about you. It also includes information about your transactions with us such as the type and value of investments that you own.

Financial Information. Financial information is certain information covered by the Fair Credit Reporting Act and includes information such as your credit history, income, assets, investment objectives, investment experience, type and value of other investment products you own or for which you have applied.

How IFS Protects Information:

IFS employees are required to protect the confidentiality of Information and to comply with our established policies. IFS employees may access Information only when there is an appropriate reason to do so, such as to administer the firm’s products or services. IFS also maintains physical, electronic and procedural safeguards to protect Information, which comply with all applicable laws. Employees who violate our Privacy Policy are subject to disciplinary process.
